We are pleased to have celebrated 170 years of caring for the people in our community. We are proud of our history, which reflects the many changes made to ensure we are meeting the needs of the community we serve. In 1852, a group of church women started Belmont House to assist women who were in trouble with the law. They expanded early on to care for senior women and men. Throughout these 170 years, the community and government have recognized the importance of Belmont House and have reached out to encourage us to continue to meet the increasing care needs of seniors in Toronto. More about our history can be read through this Annual Report.

As we ended 2022, we reflected on our many accomplishments and challenges. 2022 was a year of many milestones. In March 2022 the Ministry of Long-term Care approved the addition of 100 long-term care beds to our current site. The need for more long-term care beds in Toronto and across the province is a result of the aging population and better utilization of hospital beds to be used for acute care patients and not individuals waiting for a long-term care home. The province has committed to adding 30,000 new long-term care beds and the redevelopment of 30,000 current beds. We began planning the Belmont project to expand long-term care beds and assisted living retirement beds and will continue these plans in 2023.

The COVID-19 pandemic which was declared in March 2020 was still a significant challenge for Toronto and the rest of the world in 2022. Even though government restrictions had lessened through the year, we continued to focus on keeping COVID-19 out of Belmont. The provincial government continued to support the efforts of all long-term care homes in ensuring a safe and comfortable home for everyone. In 2022, the province gave Belmont House \$761,000 to support our efforts in minimizing the spread of COVID-19.

Since the pandemic was declared, Belmont has continued to keep our seniors and staff safe. Many of the restrictions and infection, prevention, and control measures were reduced in 2022 which enabled people to return to many of the pre-pandemic activities.

New Government legislation was introduced because of the impact of COVID-19 on the health care system. A new long-term care act called Fixing Long-term Care, 2021 was introduced with amendments being made in 2022 to regulations. In addition, legislation called More Beds, Better Care Act, 2022, was introduced to enable hospitals to move alternative level of care patients into long-term care. This Act has been controversial given that patients may not have a choice in which long-term care home they are placed in.

On a financial level, 2022 resulted in a surplus position for Belmont House. This surplus is invested back into our community. In addition, the province's commitment to achieving 4 hours per resident per day resulted in funding that was utilized to increase staffing hours and create more full-time positions. This enhanced funding will be fully realized in 2024.

As a non-for-profit charitable home, Belmont House continues to be committed to meeting the needs of the community we serve. Our historical partnership with our community and donors has made Belmont House what it is today. The Belmont House Foundation, which also celebrated its 30th anniversary in 2022, plays a valuable role in supporting Belmont House, and we greatly appreciate their commitment to our donors and Belmont House. Through the support of the Belmont House Foundation, we were able to implement the Butterfly Model of Care on our dementia care nursing unit and are the first long-term care home in Toronto to do so. We look forward to implementing this model of care across Belmont House.

We would also like to thank the Long-term Care Resident Council, the Retirement Tenant Council, and the Long-term Care Family Council for advocating for everyone who lives at Belmont House and for working with the management team to ensure a high level of care and service.

A very special thank you to the members of the Belmont House Board and the Belmont House Foundation Board of Directors for their guidance, strength, and commitment to meeting the needs of our community today, and into the future. The many hours they have committed to Belmont House is greatly appreciated.

Belmont House has a reputation for being the Senior's Home of Choice. This would not be possible without the hard work of our employees, physicians, volunteers, and contracted services. We extend a heartfelt gratitude to them all for ensuring that Belmont House is the best it can be.

Many celebrations were held in honor of our 170th anniversary. We are proud of the past 170 years, and look forward, in excitement, to preparing Belmont House for the next 170 years. News on our expansion will be available in 2023 through our newsletters and website.

We hope you enjoy this annual report that shows many of our community enjoying themselves at the Belmont activities and look forward to seeing you at the many events planned for 2023.

Belmont House Medical Director's Report 2022

As Medical Director, I am pleased to provide this report, on behalf of our team of dedicated and caring staff, and strong and experienced leadership.

2022 was the third year of the COVID-19 pandemic. It remained a dominant issue requiring an inordinate amount of effort. I cannot overstate my gratitude to our terrific Infection Prevention and Control team, led by Hema Kirpal. Fortunately, with the success of vaccination, treatments available, and our IPAC measures, we have been able to re-deploy more energy and effort toward our primary goal of maximizing our residents' and tenants' well-being and quality of life in Belmont House, their home.

The demographics of Long Term Care and Retirement Homes has evolved, and the pace of change has accelerated during the Covid pandemic. We admit and care for more acutely ill, medically unstable, residents and tenants, and those with much more complex medical issues and interventions. While the majority of our Long Term Care (LTC) residents are elderly, younger residents with chronic ailments are cared for in LTC in increasing numbers.

In 2022, we admitted 53 residents to Long term Care. The vast majority were "crisis admissions" from acute care and related settings. There were 7 tenants who transferred from our own retirement wing. The average age of LTC residents was approximately 87 years of age, with a range of 51 to 104 years of age. There were 27 men and 93 women as of December 31, 2022.

We admitted 21 new retirement tenants in 2022. The average age of tenants was 90. There were 20 male tenants and 66 female tenants as of December 31, 2022.

One of the highlights of 2022 was the introduction of the Butterfly model of emotion-focused care in dementia, on the second floor of the Walker wing, which will be highlighted throughout Belmont House annual report. The introduction of the "Fixing Long Term Care" act was another significant event. Belmont House has long been a leader in the Long Term Care community, and will continue to be.

Looking forward, we will continue our efforts to provide exemplary care in our home. We hope to broaden our emotion-focused care model to other home areas, and our efforts continue toward expansion, to allow even more residents and tenants to benefit from the care and support that we can provide.

In closing, I would once again like to thank everyone who helps in supporting the health and the quality of life of our residents and tenants.

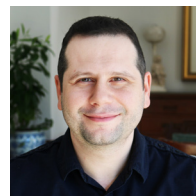

In 1992 the Belmont House Foundation was established to coordinate fundraising efforts and support the growing needs of our home. Over the last 30 years, the Belmont House Foundation has granted more than ten million dollars to our community. Supporting extended nursing and recreation staffing has ensured our beloved residents and tenants have access to the best possible medical care, stimulating and fun recreation programming, and lots of individualized time with staff. Investing in high-quality equipment such as ceiling lifts, electric beds, therapeutic mattresses, and physiotherapy equipment has meant that residents can be as comfortable as possible, and staff can attend to everyone's personal care needs without strain.

Belmont House Foundation is also committed to supporting the Belmont House staff in their education and development. A generous tuition assistance program has allowed staff to obtain their degrees, professional certificates, and reach other new levels of education. We are proud of the amazing people who work so hard to make Belmont House such a wonderful place to live.

Belmont House is known across the province as a home that provides exemplary care and service for residents and tenants, with a leadership team committed to continual improvement and cutting-edge care. Belmont House Foundation was excited to grant more than \$200,000 to support the transformation of 2 West into Butterfly Lane. We look forward to supporting each floor as they begin their own transformations.

Celebrating 170 Years of Caring

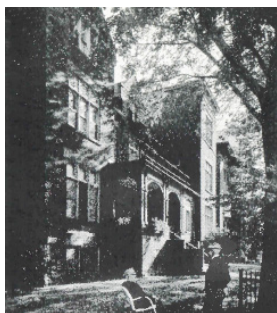
Renting a house on Richmond Street in 1852, a group of service-minded church women opened a home to meet the needs of women released from prison. Within a few years, more space was required and so a larger home “in the country beyond the tollgate” was rented on the site where Belmont House now sits. A new home was built and named the *Magdalen Asylum and Industrial House of Refuge*. The home provided women, often ignored by society, a safe space where they received comfort, care, and practical job training.

In response to the rise in older women experiencing homelessness, a wing of the *House of Refuge* was set aside for aged women. With the support of the surrounding community and a generous donation left in a will, the home grew to provide housing and care to aged women and men. In the 1880s a second home was built and named *The Aged Women’s Home*. In 1908, a third home opened with the name we all know today, *Belmont House*.

By 1940, the job training for women released from prison was taken up by government schools and the *House of Refuge* was closed and converted into *Ewart House*, named in honour of the first woman to serve as President of the Board of Management. With the newly *Tweedsmuir House*, 250 seniors lived in this community.



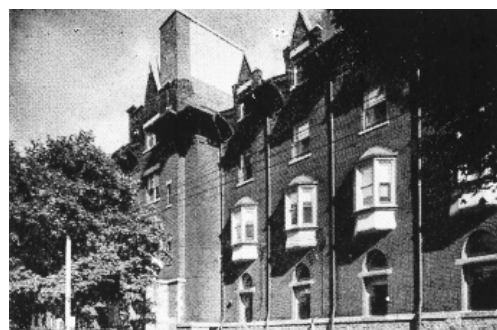

Towards the end of 1966, Toronto newspapers announced a new era for “the three old grey buildings on Belmont Street”. The three homes were demolished, and the current East building was built. Opened in 1969, the new Belmont House provided dormitory-style suites for 250 residents. The building was renovated in the 1990s into the 81 apartments and 24 Long-term Care beds we still have today.

Belmont House’s West Wing, a 5-storey building with 116 Long-term Care beds, was opened in 1992, and dedicated by the Right Honourable Adrienne Clarkson, Governor General of Canada in 2001 when the West Wing was renamed the *Senator David J. Walker Wing* after a generous donation by the Walker family in gratitude for the care Senator Walker received at Belmont House.

In celebration of Queen Elizabeth II’s Jubilee year, and Belmont House’s 150th anniversary in 2002, The Earl of Wessex, Prince Edward visited Belmont House in 2003 to dedicate the East Wing in memory of the Queen Mother, Queen Elizabeth, officially naming it the *Queen Mother Wing*.

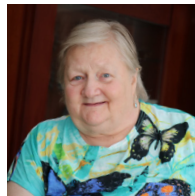
In the years since, Belmont House has continued to reach new heights of excellence. An extensive renovation of the care floors in the *Senator David J. Walker Wing* was undertaken in 2006, and of 2 East in the *Queen Mother Wing* in 2014. Recreation and spiritual programs have expanded, new therapeutic models and technologies have been embraced, and partnerships with prominent Colleges and Universities have facilitated important research in senior care. In 2022, we officially changed our legal name from *The Toronto Aged Men’s and Women’s Homes* to *Belmont House*.

Through the first 170 years of Belmont House’s history, the themes of community and philanthropy have remained strong. We hold fast to the vision of our founding mothers, striving to provide the best care possible. We are dedicated to remaining a community that supports one another and builds a strong future to continue for the next 170 years.
